MAY

May 1, 2013 - 2nd installment for the Girls' Compulsory season DUE

JUNE

June 15, 2013 - LAST day to request permission to withdraw from a L3-L5 Girls' Team Meet

June 15, 2013 - final installment for Girls' Compulsory season DUE

AUGUST

Girls compulsory season starts - *don't have the exact date - usually about the 22 - weekend before Labor Day*

SEPTEMBER

September 1, 2013 - 1st installment for the Optional Girls' season DUE - *final installment DUE November 15, 2013*

September 1, 2013 - 1st installment for the Boys' season DUE - final installment DUE November 15, 2013

September 1, 2013 - ALL UNIFORM FEES & Booster fees for BOYS and OPTIONAL GIRLS DUE

September 1, 2013 - ALL Boys' and Optional Girls' signed contracts DUE

OCTOBER

October 1, 2013 - 2nd installment for the Optional Girls' season **DUE**

October 1, 2013 - 2nd installment for the Boys' season **DUE**

NOVEMBER

November 1, 2013 - payment for the Girls' Compulsory State meet **DUE**
